Assistant Superintendent's Message

NHS Earns Year 6 Approval and Advances CLASS Quality Efforts

Thank you for your continued dedication and teamwork. With support from Superintendent Edgewater and Chair James (HEHSC), NHS successfully completed the NHS/OHS Tribal Consultation on January 27, 2026, and was approved for Year 6 with no impact on funding.

The School Readiness Team will continue partnering with OHS Training and Technical Assistance to strengthen CLASS implementation across all preschool classrooms. A follow-up review is scheduled for October 2026. Maintaining strong emotional support, classroom organization, and instructional support will remain essential for meeting quality thresholds.

NHS is also preparing to resubmit the Change in Scope Application to the Office of Head Start. Using five-year data trends, the goal is to establish a realistic enrollment target while maintaining current grant funding. This work will include updates to the Program's Plan of Operation, Organizational Chart, and service listings. We look forward to continued collaboration with Policy Council, the Navajo Nation Board of Education, and the 25th Health, Education and Human Services Committee.

On behalf of NHS Central Administration, Thank you for providing high-quality, culturally grounded services to our children and families.

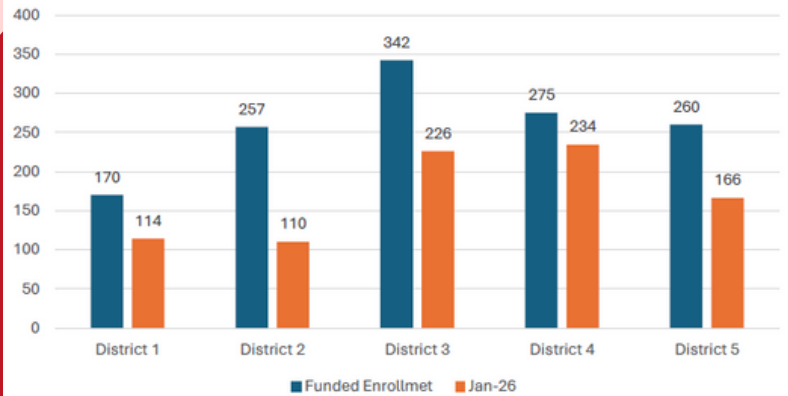

ERSEA

Report: February 2026

Greetings Navajo Head Start Staff. I hope this month brings you lots of love, support, and reassurance. ERSEA has been working hard to enroll children and families to help increase our enrollment program wide. Recruitment efforts and strategic planning has been the priority goal to keep enrollment trends moving forward. The enrollment for the ending month of January 2026 was set at a grand total of 856 of 1350, with Early Head Start at 101 for enrollment slots filled and Head Start at 715 filled. During the month of January 2026, there was a total of 40 withdrawals that occurred in both programs. The withdrawals reasons range from a variety of family concerns and program concerns. The goal for ERSEA for the month of February is to decrease the number of withdrawals by at least 75%. ERSEA will not be able to reach that goal without the help of center staff. We appreciate your support, dedication, and hard work that you do daily to ensure Navajo Head Start is a prime example of a Navajo program providing quality services to all our children

Enrollment February 2026 Recruitment Calendar:

These are the locations where the ERSEA team are going to conduct recruitment efforts for the month of February 2026. These locations are based off the communities who have Head Start and Early Head Starts sites that do not meet the enrollment threshold of 85% funded enrollment. We are approaching the end of our third quarter for the school year. Keep in mind that the 2 tier for under-enrollment notifications will be going out the month of March. The second (2) tier threshold does increase from 85% to 90%. ERSEA is seeing some enrollment movement within each district. Continue to recruit children and families. ERSEA appreciates all support from center staff during these times.



Summary

As we move into the second semester of the school year, the Mental Health and Disabilities (MHD) team would like to remind staff of the 10% Enrollment Requirement. Head Start programs are expected to ensure that 10% of their actual enrollment includes children eligible for services under the Individuals with Disabilities Education Act (IDEA). This requirement—established in 1972—helps ensure that children with disabilities, developmental delays, and their families have equitable access to Head Start services.

There is no limit on the number or percentage of children with disabilities in a program. Enrollment in Head Start programs supports early and timely intervention services that make a profound difference for children with disabilities and their families. Because of that, Head Start programs are required to ensure that a minimum of 10% of slots be occupied by children with disabilities. There is no limit to the number of children with disabilities who should be in a single classroom. Children with identified needs receive priority for enrollment and services.

Currently, NHS is at 6.8% of actual enrollment for children eligible for services under IDEA. As we move through the school year, our goal is to increase this percentage and work toward reaching the 10% requirement by year's end.
